I, _____ (full name), as a natural and sovereign citizen of Newfoundland and Labrador, am making a formal criminal complaint against the following individuals:

These individuals have collectively, jointly and severally, breached the criminal code of Canada section 346(1) regarding Extortion.

They have further broken accordances and legal rights listed in the Canadian Bill of Rights, provided, S.C. 1960, c. 44 assented to 1960-08-10

The individuals named above have through any means necessary created a situation in the province of Newfoundland and Labrador that is extraordinary to the law in denying the rights and freedoms of certain individuals who are citizens and residents of the province by dividing them into two groups, those who comply with government mandates that do not carry the weight of law, and those who do not.

I hereby attest on oath, that the individuals above, acting outside of the legislature of Newfoundland and Labrador, are using extortion, coercion and other inducements as a means of forcing citizens into accepting experimental medical treatments, using super-legal identification means and proof thereof, and unilaterally imposing penalties that are exceptional to the legislature and have not been enacted into law.

The burden of proof of the charge of Extortion is met by the following conditions:

1. The promise of a return to normal life will be fulfilled once citizens are injected with emergency use approved vaccines from Pharmaceutical companies Pfizer-BioNTech, Moderna and AstraZeneca. Failure to comply will result in reduced rights and privileges guaranteed under the Canadian Bill of Rights and the Charter of Rights and Freedoms (section 25 of the Canadian Constitution). Also violating section 2 of the Charter of Rights and Freedoms
2. Travel will not be permitted for work or personal requirements unless individuals and companies are compliant with the mandates issued by the aforementioned individuals - which means a reduction in income for individuals and companies requiring travel to conduct business affairs and trade. Also violating section 6 of the Charter of rights and freedoms.
3. An unknown number of injections must be taken by individuals and recorded and presented in a "Vaccine Passport" to conduct normal affairs required in the course of making income for the survival of individuals and companies. Without such, individuals and private companies will result in a loss of income and possible financial harm to even bankruptcy. Also violating section 15 of the Charter of Rights and Freedoms.
4. To do business at any establishment not considered essential, by an arbitrary decision made by the individuals listed above, is prohibited without compliance to these vaccine and vaccine passport mandates that have not been put into law and are being forced above the public.
5. I have personally lost considerable income and opportunity in my business and professional career due to my reluctance to be coerced into accepting experimental medical treatment (documented in attachments).
6. The promise made that I may possibly have all these rights and freedoms returned to me if the conditions of these mandates are met, is prima facie of extortion in accordance with the Criminal Code of Canada.
7. I am forced to use an agent or alternate means to obtain, buy or sell, within the Newfoundland and Labrador (and Canadian) economy and thus procure the necessary means to live and provide for my family. This is a violation of the Bill of Rights and Charter of Rights and Freedoms previously cited, and extortion is being used to allow myself as an individual to re-obtain these rights and freedoms.

Further to this, I have personally witnessed human medical harm resulting from the use of these experimental treatments that are under human/clinical trials until 22 December 2022 as per the WHO, CDC, NIH, and Health Canada.

The forced, coerced use of medical treatments to operate as a participant in normal life and economic activity within one's own country is a violation of several articles of the Nuremberg Code, to which the country of Canada is a signatory and sworn to uphold.

I hereby declare my personal rights and freedoms enshrined by law in Canada and press these rights for the Crown Prosecutor of Newfoundland and Labrador to take immediate action and file charges against these individuals under section 346(1) of the criminal code of Canada and breach charges for violating my human rights.
